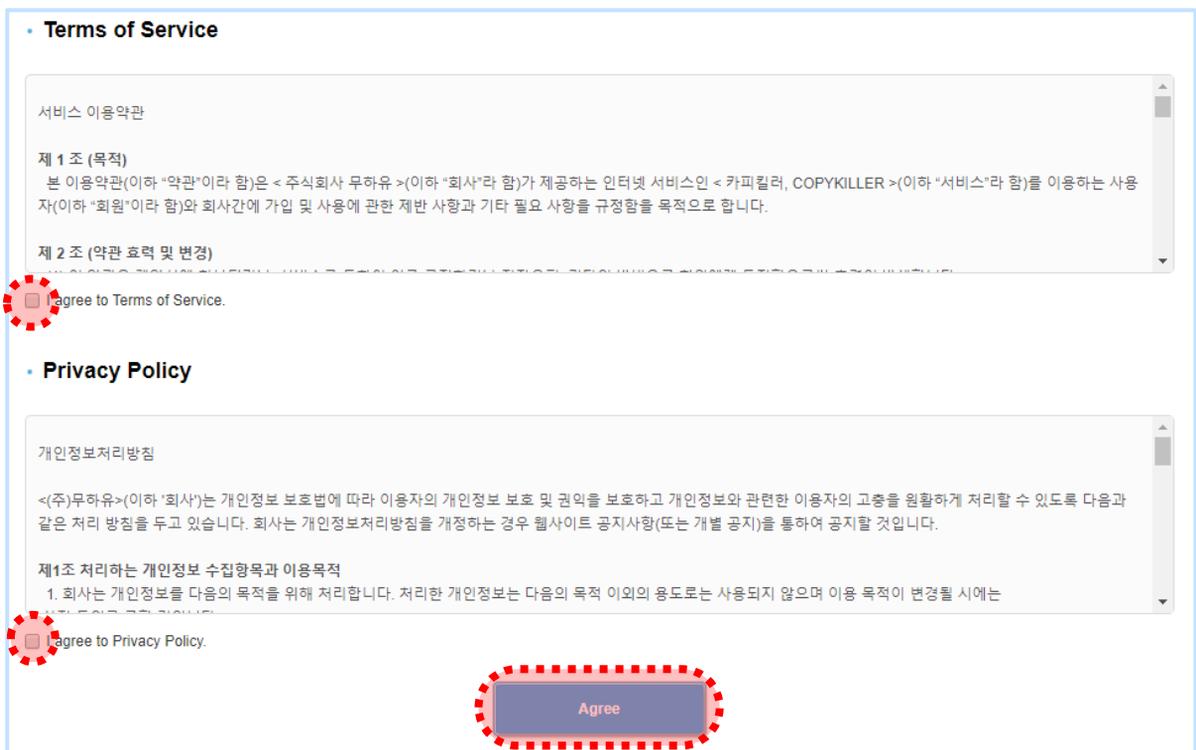


2.1 Terms and Conditions agreement

2.2 Entering Personal Information

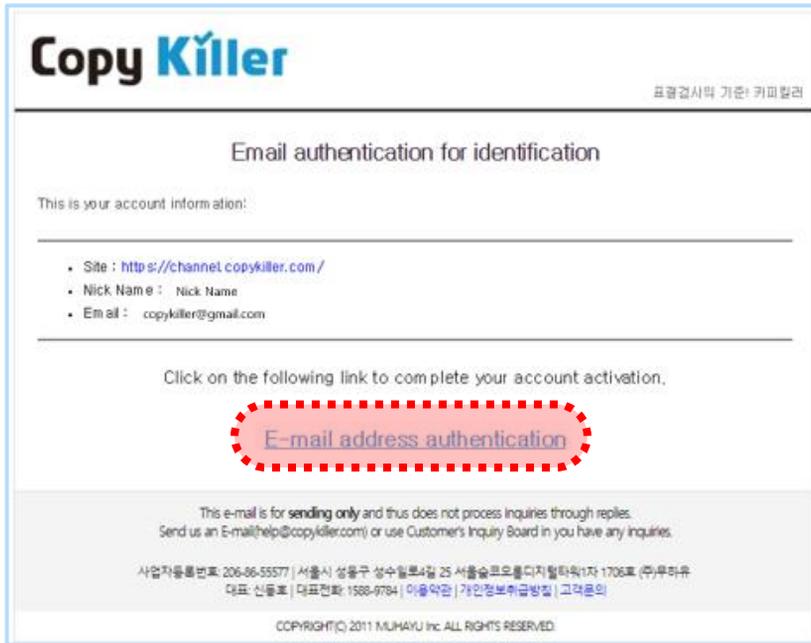

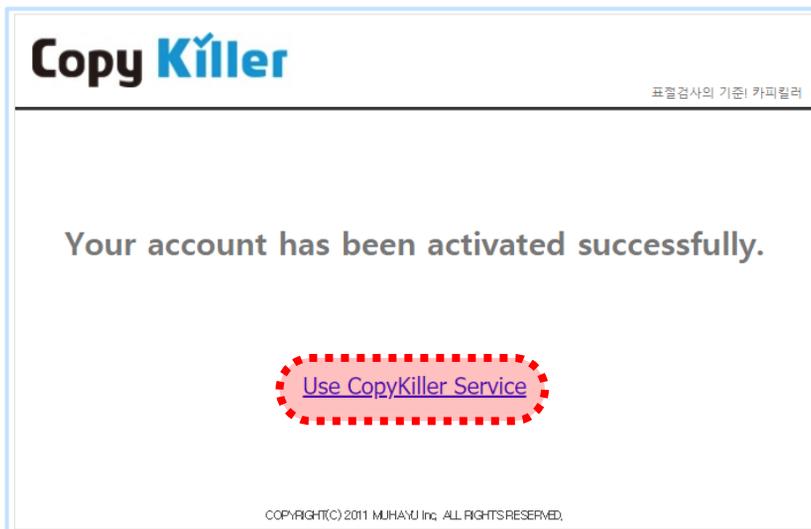

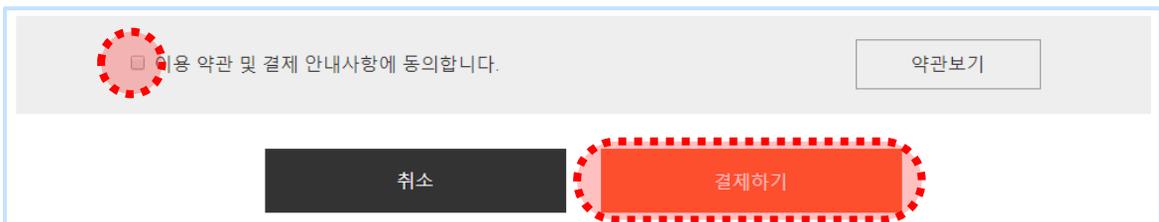
Select either pay credit card or send money.

4.1 Upload & Inspection Setup

- ① **Upload:** Select Upload in the upper right corner to start the procedure.
 - ② **Title :** Feel free to write down your title. (Write it down carefully as it will appear on the results confirmation form.)
 - ③ **Purpose :** Set to the ' for checking '.
 - ④ **Document Type :** Select the type of document.
 - ⑤ maintain default settings to **Comparison Scope, Setting, and Matching Rules**
- i** If the organization you are about to submit has a set criteria, then check them accordingly.

5.1 Inspection Setup

- ① **Title** : Title: Enter any description to recognize which document you checked
(This is the name that is displayed in the examination result confirmation document)
- ② **Purpose** :
 - For Checking : The target document you want to check. This document will be scanned whether it copies other document or not
 - For Comparison : This documents will be used as a comparison pair with your target document.
- ③ **Document Type** : Select one form fits on your document among 'Assignment', 'Self-Introduction', 'Dissertation', 'Journal Article', 'Research Paper', 'Book Review', 'Press Release', and etc.
- ④ **Comparison Scope** : The ' Current Attachments ' is compared to the currently attached documents. 'My Documents ' is compared to the one I uploaded earlier. 'Copy Killer DB ' compares to the documents collected by the copy killer.
- ⑤ **Setting** : Set whether to include or exclude quoted / source statements, statute / Bible statements, table of contents / references in the plagiarism rate. Although ' exclusion ' is the default setting, setting it to ' include ' will result in a high plagiarism rate because the sentence is included in the plagiarism rate.
- ⑥ **Matching Rules** : You can set the number of syntactic word and sentences according to the purpose of the examination. The basic criteria are set according to the guidelines of the Ministry of Education in Korea.

5.2 Registering documents & conducting an examination

① **Select File or Enter Text :**

① a **Select file :** Select files you want to upload.

① b **Enter Text :** Enter or paste text on the writing panel.

② **Status :** Once the registered document has been changed to 'Possible', you can proceed with the examination.

③ **Submit :** Select ' Submit ' below to proceed with the plagiarism test.

7. Detailed Results

- ① **Plagiarism Rate** : I can see the plagiarism rate of the documents I posted.
(Word segment recognized as plagiarism / Full Word segment of the document*100)
- ② **Download Report** : You can download the results confirmation and it is provided in PDF format.
- ③ **All Sentences** : Displays the number of sentences analyzed. Click on each of the sentences to find the appropriate information.
- ④ **Setting** : Use the buttons to freely modify the settings.
- ⑤ **Original Document** : Check the text content of the original document and the plagiarism rate for each sentence.
- ⑥ **Matched Sentences** : Identify sentences and sources recognized as plagiarism.
- ⑦ **Matched Sources** : Lets you know the information in the document.

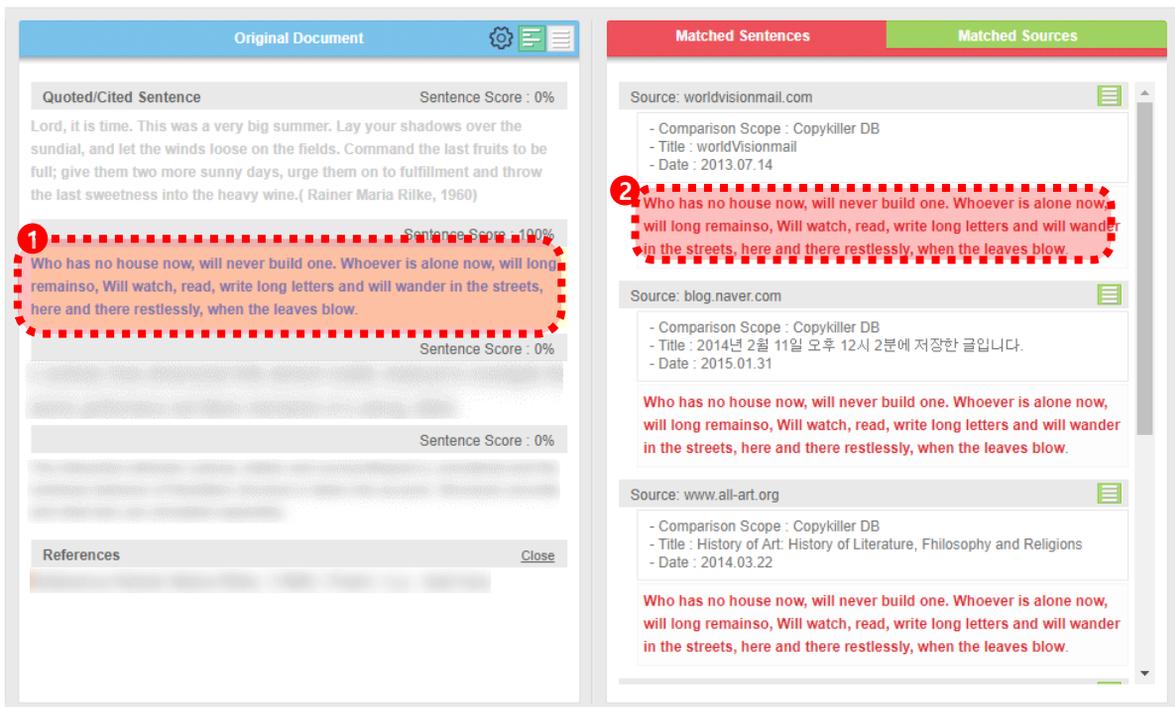

7.1 Sentence Comparison

The information in the comparison sentence tells you which sentences are compared. You can check the contents of the sentence and its scope.

- ① **An area of plagiarism recognition in an original document** : It is displayed in the **Blue font** of the original document.
- ② **Areas recognized as plagiarism in Matched Sentences** : It is displayed in the **Red font** of the matched sentences.

 Click on the blue characters on the original documents to see the right matched segments.

7.2 Matched Sources(Document Comparison)

Click on " Matched Sources " to find out which documents are compared. You can check the information in the documents that contain comparison sentences.

- ① Select ' Matched documents ' to see a list of compared documents.
- ② Check the names of the documents and the plagiarism rate by document. You can click on the document name to find out source information.
- ③ If you scan a document that has already been registered, the same document may be compared to each other and have a high plagiarism rate. Select the x button to the right of the document name, and then press apply in the upper right corner. You can then see the results compared to the rest of the documents except that one.

However, even if you exclude it, the list will be displayed on the result confirmation form.

 For more information on how to exclude comparison documents, see How to exclude publication documents on 25p.

You may receive confirmation of the results of the examination.

① Select ' Download ' on the Result > Outline screen to download the PDF version of the transcript.

9.1 1:1,1:N How To Compare

Do you have a specific document you want to compare? You can compare 1:1 or examine with 1 : N. You can also check the results of a comparison document that you have registered.

① Change the Purpose to ' For Comparison ' in the upload screen. Write the Title and register the document to be compared.

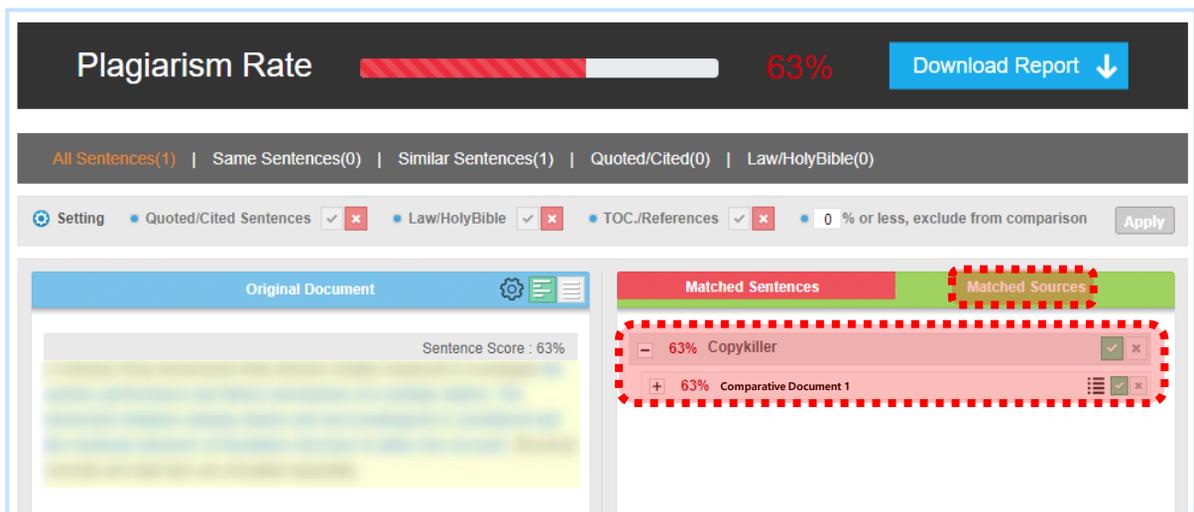

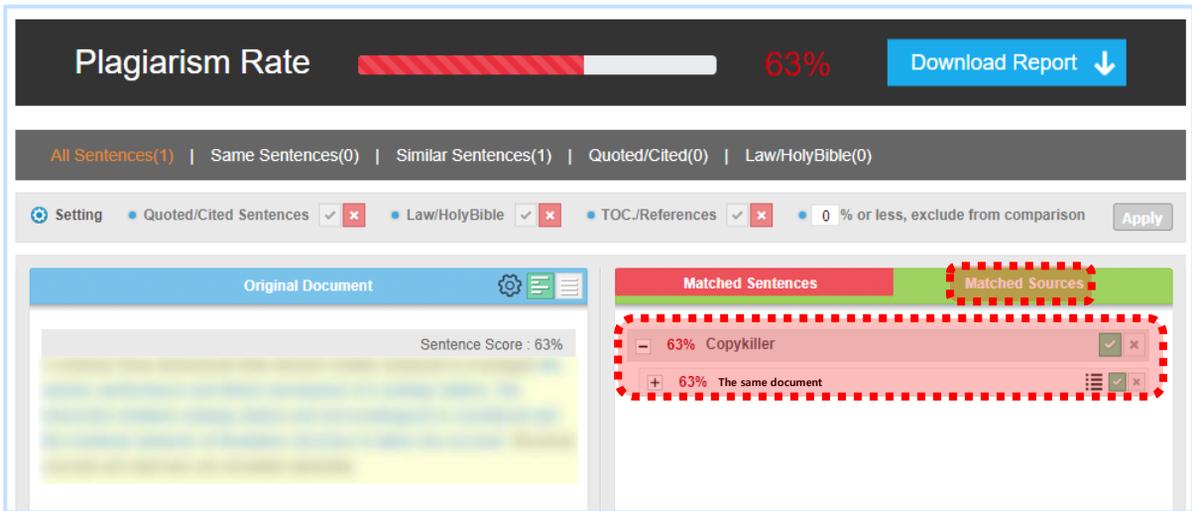
- i** To check the results of a comparison between an inspection document and a comparison document
 - ① Proceed to the upload procedure from the upload screen.
 - ② Enter the Title.
 - ③ Select " For checking".
 - ④ Select Document Type.
 - ⑤ For the Comparison Scope, select Between Attached Documents only.
 - ⑥ Select Setting, Matching Rules.
 - ⑦ Register the document you want to compare with the document you want to examine at one time.
 - ⑧ Click Submit when status is ' appropriate'

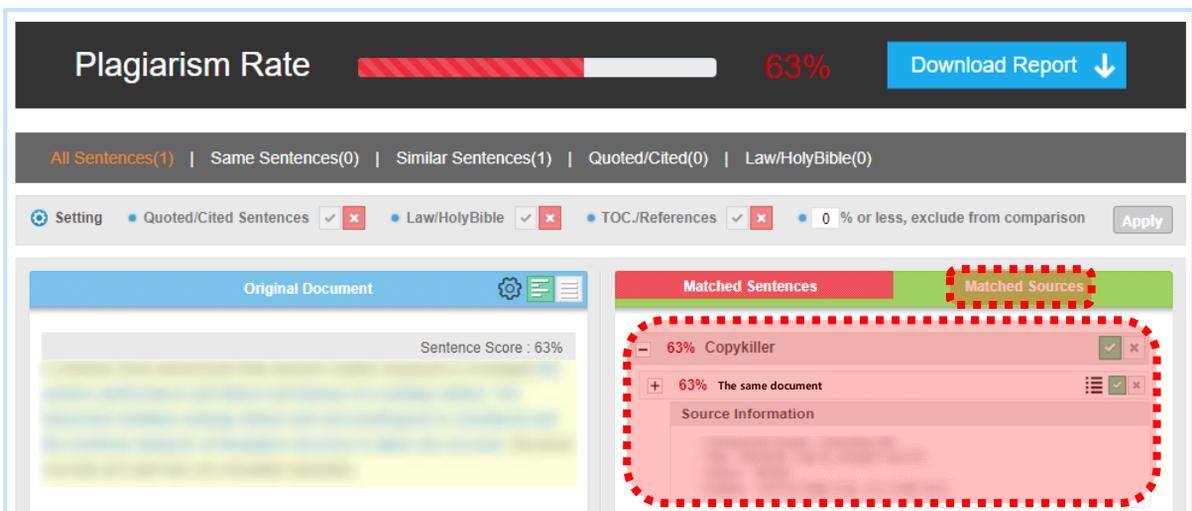
9.2 Exclude comparison documents you've

If the document you are examining is already published or registered, it may be included in the copy killer's DB, which may result in a high level of plagiarism due to comparisons between the same documents. The document can be excluded from the inspection results through the establishment method.

① You can see the same title as the document you examined in Matching Sources on the Detailed Results screen.

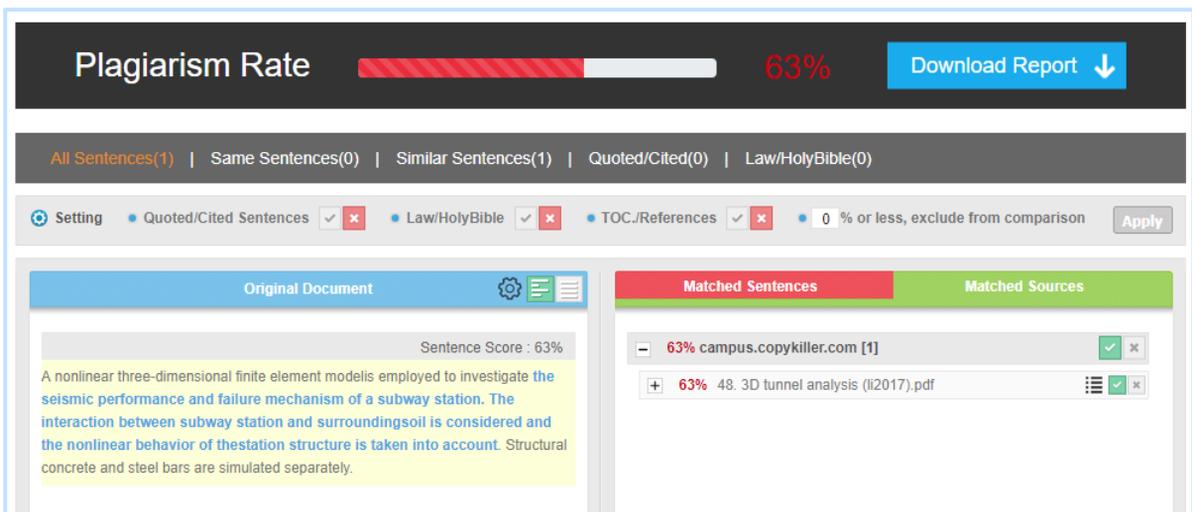


② Under Matching Sources, click on the same document title to view its contents.

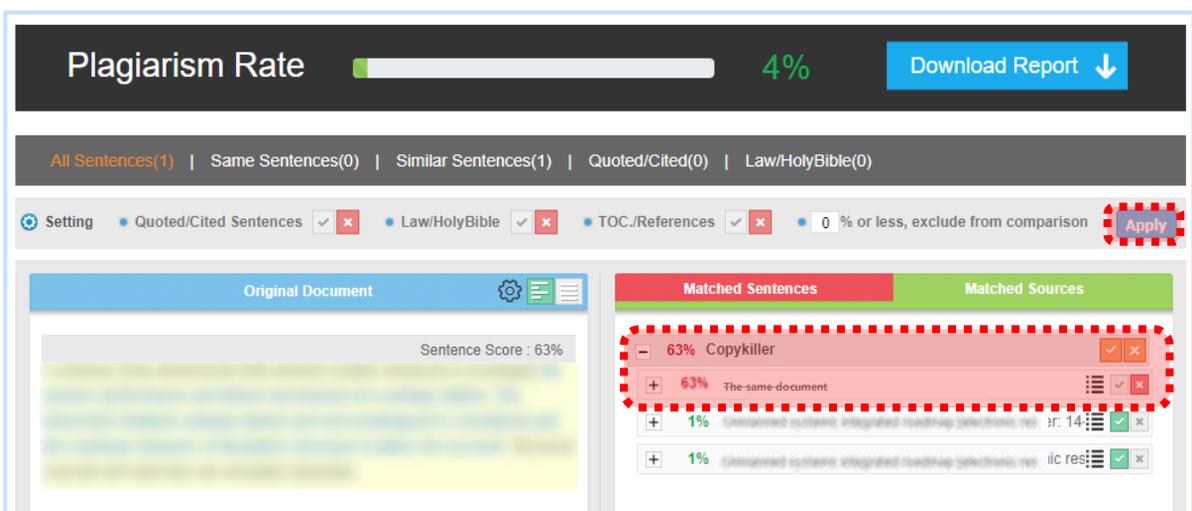

- ④ The same documents after the year of publication of the document examined are also excluded.

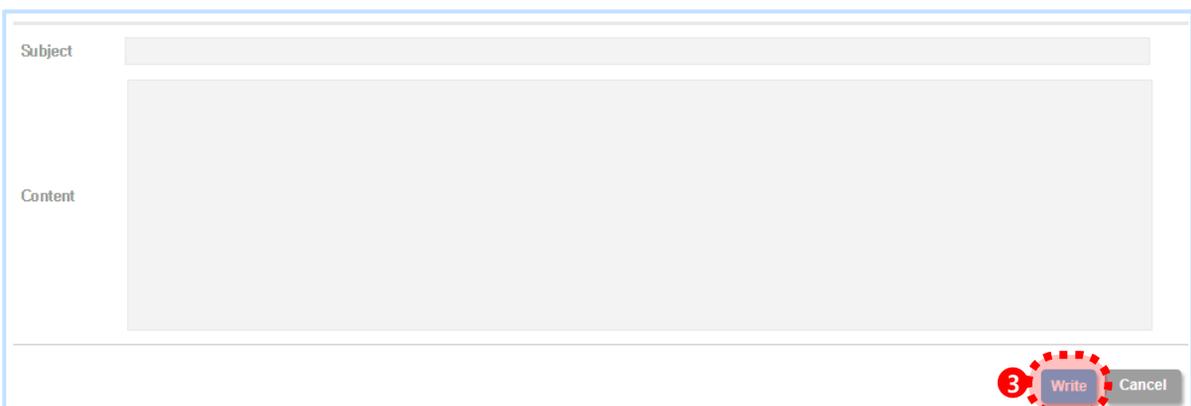
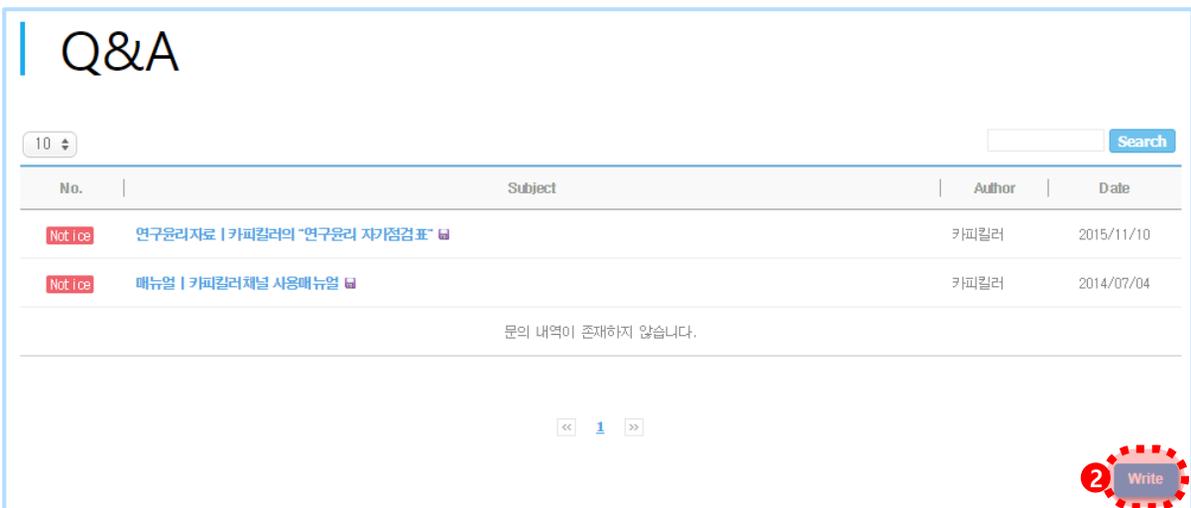

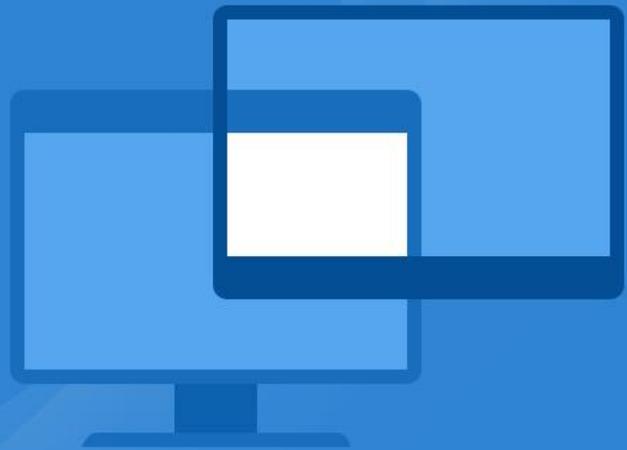
